- 1. Office of Municipal Executive, Beni Municipality invites sealed bids or electronic bids from eligible bidders for the following projects under National Competitive Bidding procedures.

- 3. A complete set of Bidding Documents may be purchased from the Office of Municipal Executive by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate for Different Package till 2075/01/20.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 4. Pre-bid meeting shall be held at Office of Municipal Executive ,Beni Municipality, Myagdi at 2:00 PM on 2075/01/05. The attendance in pre-bid meeting is optimal but interested bidders are encouraged to attend to the pre-bid meeting.
- 5. Sealed or electronic bids must be submitted to the Beni Municipality by hand/courier or through PPMO website www.bolpatra.gov.np. on or before 12:00 Noon on 2075/01/21. Bids received after this deadline will be rejected.







- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2075/01/21 at the Beni Municipality. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 8. Bidders are required to specify the total price of the bid in the letter of bid or the bid price in the summary of bill of quantities. Failure to specify the total price of the bid in the letter of bid or in the summary of quantities shall be ground for declaring the bid non responsive.
- 9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
- 10. Any Modifications and withdrawal in case of hard copy Bid submission should be before 24 hours from deadline of Bid submission except electronically submitted bid. The modifications and withdrawal letter should be submitted in sealed envelope otherwise it will not be valid.
- 11. Any information otherwise stated in this notice will be as per Public Procurement Act-2063(First Amendment 2073) & Public procurement Rules (Forth Amendment 2073).
