- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on 2078/01/27 at the office of Municipal Executive, Beni Municipality. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 85,000/-, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Dharauti Khata which is mention above and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.


7. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
