- Pre-bid meeting shall be held at Office of Municipal Executive, Beni Municipality, Myagdiat 2:00 PM on 2076/11/11. The attendance in pre-bid meeting is optimal but interested bidders are encouraged to attend to the pre-bid meeting.
- Bids must be submitted through PPMO website <u>www.bolpatra.gov.np/egp</u>. on or before 12:00 Noon on 2076/11/28. Bids received after this deadline will be rejected.
- 6. The bids will be opened at \$\frac{1}{2}\$:00 pm on 2076/11/28 at the Beni Municipality in the presence of Bidders' representatives who choose to attend but attendance is not mandatory. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the bid validity period. The scanned copy of bid security, bid document fee voucher, company/firm, registration, renewal, tax clearance certificate should be uploaded at the time of bid submission.
- 7. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 8. Bidders are required to specify the total price of the bid in the letter of bid or the bid price in the summary of bill of quantities. Failure to specify the total price of the bid in the letter of bid or in the summary of quantities shall be ground for declaring the bid non responsive.
- The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
- 10. Any information otherwise stated in this notice will be as per Public Procurement Act-2063(First Amendment 2073) & Public procurement Rules (Forth Amendment 2073).
